New Zealand's ICESD policy states that we advance sustainable development through our integrated approach, which includes trade, security, environment and diplomatic cooperation. (https://www.mfat.govt.nz/assets/Aid-Progdocs/Policy/Policy-Statement-New-Zealands-International-Cooperation-for-Effective-Sustainable-Development-ICESD.pdf) Alongside this policy, New Zealand has a nonbinding commitment under the Pacific Agreement on Closer Economic Relations (PACER) Plus to channel 20% of our International Development Cooperation (IDC) funding to Aid-for-Trade in the Pacific (https://www.mfat.govt.nz/en/trade/free-tradeagreements/free-trade-agreements-in-force/pacer-plus/).
