Aid for Trade is mentioned among the Development Cooperation priorities in the Development Cooperation and Humanitarian Aid Strategy of the Republic of Slovenia until 2030, specifically mentioning SDG target 8.a (Increase Aid for Trade support for developing countries, particularly least-developed countries, including through the Enhanced Integrated Framework for Trade-Related Technical Assistance to Least Developed Countries) and with the following justification: "Decent work for decent pay is the basis for eliminating poverty and inequality. Favourable conditions for business development in partner countries, which is environmentally friendly and offers equal opportunities to both genders, facilitate better adaptability of the economy of the partner country to the situation in the domestic and international market and foster innovation. Poverty can also be reduced or eliminated by fostering trade and participating in the global economy. As a result, attaining EU standards and thereby cooperation in the European single market is particularly important to partner countries which have a European perspective and an association agreement with the EU. As to countries of sub-Saharan Africa, it is vital that they receive support for entering the global economy on the basis of economic partnership agreements with the EU."
