In Mexico, the economic empowerment of women is promoted as part of the priorities of the National Policy on Equality between Women and Men, which is generated by the provisions of the General Law on Equality between Women and Men. This policy consists in the National System of Equality: the National Programme for Equality between Women and Men (Proigualdad); and the enforcement, monitoring and evaluation mechanism, under the responsibility of the National Human Rights Commission. For the period 2013-2018, the National Programme for Equal Opportunities and Non-Discrimination against Women was implemented, with six cross-cutting objectives, including number three, which sought to promote women's access to paid work, decent employment and productive resources. In addition, the current Rules of Operation of the National Program for Financing Microentrepreneurs and Rural Women (PRONAFIM) establish within their specific objectives the promotion of gender equality and contribute to the empowerment of microentrepreneurs through access to microfinance services. In addition, this Program is aligned with the National Development Plan (PND) 2013-2018 in the "Mexico Próspero" Axis, which guides the actions of the federal government to trigger the sustained growth of productivity through the generation of equal opportunities. In the area of SMEs, the national policy is based on Strategy 4.8.4 of the NDP, which seeks to promote entrepreneurs and strengthen micro, small and medium enterprises.

Proigualdad focuses its transversal objective 3, on women belonging to the economically active population, i.e. women inserted in the labour market or actively looking for work. PRONAFIM aims to provide microfinance services to microentrepreneurs in order to promote the creation of economic units and increase the productivity of existing ones.

The indicators established in Proigualdad 2013-2018 for cross-cutting objective 3 are the following: first, female participation rate in the labour market, with a target of 48% by 2018; second, wage discrimination rate by sector of activity, with a target set for the same year to reduce inequality by at least 20% by sector of activity; and third, percentage of employed women who do not have access to childcare, with a target of 75% by 2018. For the period 2013- 2018, PRONAFIM reported the sectoral indicator entitled "Women's participation in productive activities financed with FINAFIM resources," which shows the participation of women microentrepreneurs in economic activities financed with resources from the Trust Fund of the National Microenterprise Financing Program (FINAFIM). This indicator is framed in the actions for the fulfillment of the National Program of Innovative Development 2013-2018. Objective 4 (Mexico Prospero) of the National Development Plan. Women's SME Program This program promotes the development of women entrepreneurs through financing with preferential characteristics. It is aimed at micro, small and medium enterprises led by women, of any trade, industry or service, who need financial resources to grow. It is promoted by the National Women's Institute (INMUJERES), the National Financial Institute (Nafin) and the National Entrepreneur's Institute (Inadem). To participate you need to be a woman, be between 18 and 75 years old, and own a business in the formal regime. The main benefits are: access to financing with preferential interest rates and the elimination or reduction of guarantees with respect to other products available in the market. No collateral or joint and several liability is requested for loans of up to 500 thousand pesos, and no mortgage guarantee is requested in amounts of up to 2.5 million pesos. The program reaches the target population through commercial banking. In order to obtain financing, entrepreneurs must go directly to the banks that manage the program, which will evaluate the financial situation of the business, that there is an adequate credit history, that the legal and financial information is up to date, and will make the decision on the approval of the credit. Until August 2018, 11,240 loans for 12,412 million pesos have been granted for working capital and the acquisition of fixed assets. Since the creation of INADEM in 2013, support has been given to the empowerment of women. Thus, in 2014, the Moving Women Mexico program began operations, with the objective of providing women entrepreneurs with access to resources, networks, information, technical and administrative assistance so that they can prepare their negotiation plans and have all the elements to start or grow their business. From 2015 to 2018 the Youth Credit and SME Women programs were well accepted; however, the lack of budgetary resources allocated in 2017 and 2018 limited their impacts.

On the other hand, the Women Moving Mexico program operated by INADEM in coordination with CREA A.C. was subject to an impact evaluation by the World Bank, with very good results for the participants. Therefore, it would be very important for these types of programs to continue operating.
